- 1. Call to Order

- 3. Audit Presentation of financial statements for the year ending June 30, 2019 by Sarah Budenske, CPA
 - Significant changes:
 - Purchased the Chanhassen store building in May 2019. Accrued real estate taxes for Chanhassen-decreased income \$79,486
 - Signed a lease amendment for Minnetonka store, extending lease terms to July, 2029.
 - Confirmed the financial statements present fairly in all material respects, the financial position of Lakewinds Natural Foods as of June 30, 2019 and 2018.
- 4. Patronage Dividend discussion by Sarah
 - Ryan Reichenbach moved to approve patronage base of \$1,431,284.06 and Cash allocation of 1% member sales of \$432,673.60. Christina Meyer-Jax seconded. Motion carried.
